These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by The City of New Orleans.

REQUEST FOR RELEASE OF FUNDS

On or about November 26, 2025, The City of New Orleans Office of Community Development will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of previously expended grant funds to undertake a project known as Passive Greenspace The proposed project includes the no cost transfer of the vacant parcel, totaling 0.4 acre, located at 3617 3rd Street, New Orleans, Louisiana, 70125, from the New Orleans Redevelopment Authority to the City of New Orleans for use as passive greenspace. This site is adjacent to 3621 and 3623 3rd Street: two properties currently being used for stormwater management/hazard mitigation. At this time, future development or other use of the proposed project site has not been identified; however, it is never intended to be used as a park or a playground.

The project as described above will use approximately \$0.00 of federal funding.

FINDING OF NO SIGNIFICANT IMPACT

The City of New Orleans has determined that the project will not have a significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. All comments received by November 25, 2025, will be considered by this office prior to authorizing submission of a request for release of funds. ENVIRONMENTAL CERTIFICATION

The City of New Orleans certifies to HUD that Tyra Johnson Brown, Director of Housing Policy and Community Development in her capacity as Certifying Officer for Environmental Review for the City of New Orleans consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these

responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of New Orleans to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the City of New Orleans' certification received by December 11, 2025, or a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer or other officer of the City of New Orleans; (b) the City of New Orleans has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to:
