

NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND INTENT TO REQUEST RELEASE OF FUNDS

These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by The City of New Orleans.

REQUEST FOR RELEASE OF FUNDS

On or about November 25, 2025, The City of New Orleans Office of Community Development will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of National Disaster Resilience Competition (NDRC) grant funds under Public Law 113-2 of the Disaster Relief Appropriations Act of 2013, to undertake a project known as the NDR004 – Pontilly Neighborhood Green Infrastructure.

The proposed project will consist of the installation of additional public space amenities that will further enhance other previously completed Federal Emergency Management Agency (FEMA) Hazard Mitigation Assistance Grant program (HMGP) storm water improvements and tree plantings. Elements of the proposed project potentially include additional plantings, paved walking and bike paths, enhancements such as seating, lighting, and litter receptacles, art and signage to highlight the history and stories significant to the neighborhood as well as educate residents of the importance of green infrastructure to improve drainage and reduce flooding and the installation of a pedestrian bridge across the canal to increase connectivity and cohesiveness between the Pontchartrain Park and Gentilly Woods neighborhoods.

This phase of the project as described above will use approximately \$3,393,300.00 of the City of New Orleans' CDBG-DR federal funding under grant number B-13-MS-22-0002. The total cost for the complete project is approximately \$3,393,300.00

FINDING OF NO SIGNIFICANT IMPACT

The City of New Orleans has determined that the project will not have a significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Any individual, group, or agency may submit written comments on the ERR to the City of New Orleans Office of Community Development. All comments received by November 24, 2025, will be considered by this office prior to authorizing submission of a request for release of funds.

ENVIRONMENTAL CERTIFICATION

The City of New Orleans certifies to HUD that Tyra Johnson Brown, Director of Housing Policy and Community Development in her capacity as Certifying Officer for Environmental Review for the City of New Orleans consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of New Orleans to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the City of New Orleans' certification received by December 11, 2025, or a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer or other officer of the City of New Orleans; (b) the City of New Orleans has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to:
