Motion: Deny the request for retention of the removed roof ridge tiles, decorative roof finial, wood shutters, and slate chimney caps, and to deny the request for retention of the inappropriate fences/gates and visually prominent HVAC equipment and screening. New or salvaged elements to match the previous must be reinstalled at the exterior to replace the elements removed previously without approval. All inappropriate fencing and gates must be removed (or) replaced with new opaque wood fence/gates that meet the HDLC Design Guidelines and CZO requirements. The HVAC units, platform, and screening in the right-side alley must be removed or relocated to a new position on the site that meets the setback requirements and is minimally visible or not visible from the public right of way.
