## B. 4100 Royal

Application: Review and comment only for the new construction of four-story multifamily building for 82 apartments and leasing office on a vacant lot.

Recommendation:

At that time the Commission made the following comments regarding the current proposal:

- 1. The site plan responds well to the previous ARC recommendations: Improvements made since original proposal
  - Parking lot
  - Vehicular circulation
  - Preservation of certain large trees
- 2. However, other elements of the current proposal fall short of previous recommendations:
  - The current plan eliminates responsiveness to context
  - Fewer building entrances (3-4) whereas the previous had 15-20
  - Elimination of the "townhouse" forms in the massing
  - Balconies
  - The current proposal indicates some double-hung windows instead of doors with "Juliet" railings which are at odds with the neighborhood context

The Commission made the following recommendations:

- Consider detailing the proposal so that it more closely aligns with previous ARC comments.
- 2. Improve transparency and connectivity at the ground level conditions.
  - Adding more doors will improve relationships to neighborhood rhythms and patterns as previously articulated by the client's own diagrams about entry conditions.
- 3. Reconsider "Juliet balcony" conditions which seem to no longer function and only mimic an historic balcony when it does not perform as one.
- 4. Reconsider how the proposed fiber cement paneling referred to in the drawings is detailed.
  - Current drawings do not accurately/adequately represent actual joint conditions. If built as currently detailed they will not weather well.
- Parapet height
  - No parapet is currently indicated
  - This is an opportunity to increase the height of the building
  - Will more readily conceal proposed mechanical equipment
  - CZO requires screening of such equipment.
- 6. The Commission hopes that there is a willingness to revise the plans to be more responsive to the ARC recommendations and the neighborhood scale and context.

## D. 2318 Burgundy St

Application: Retention of removal of one (1) masonry chimney from left-side structure without a Certificate of Appropriateness, and request to remove existing asphalt shingle roofing for replacement with new standing seam metal roofing at (2) two Contributing rated one-story, single-family residential buildings on a single lot of record, including removal of existing roof ridge tiles from the left-side structure.

Motion: Deny the request for retention of the masonry chimney removed previously without HDLC approval based on the HDLC Design Guidelines and because the noted storm damage and deterioration was not documented by the owner, because the exterior chimney was relatively simple in form/detail, the interior chimney remains intact, and because it is an important exterior architectural element that was highly visible from the public right of way. The Commission also included a proviso that the full chimney must be repaired, reconstructed, and reinstalled above the roofline to match the previously existing condition, materials, detailing, and appearance. Additionally, the Commission noted that if mortar repair at the interior portion of the chimney is required, HDLC strongly recommends utilizing the standard HDLC lime-based mortar formula as this will be most compatible with the existing historic masonry. This specification should be obtained from HDLC staff.

The Commission also voted to deny the request for installation of new standing seam metal roofing at the two structures because this is not considered an appropriate roof material for the historic buildings based on the HDLC Design Guidelines, the high visibility of the roofs from the street, and because the original roof material was confirmed to be true slate. HDLC recommends the applicant instead consider a standard or Fortified roof using either asphalt/fiberglass roof shingles or aluminum metal shingles (such as Permalock) which more accurately replicate the appearance of true slate, allow for the existing roof ridge tiles to remain, and can be approved at the staff level.
