AN ORDINANCE to amend and reordain Section 70-562 of the Code of the City of New Orleans to update the existing Board of Zoning Adjustments fees and create a tiered fee structure for applications based on land use categories; and otherwise to provide with respect thereto.

WHEREAS, adjusting the Board of Zoning Adjustments fee structure based on land use categories will more accurately reflect the departmental resources required to evaluate each request; NOW THEREFORE

7	(1)	Residential, including additions and accessory buildings:
8		a. Single- and twó-family dwellings:\$150.00\$250.00
9		b. Multiple-family-dwellings (three or more units) Small multi-family/townhouse
10		dwellings (3-6 units): \$250.00
11		c. Large multi-family/townhouse dwellings (7+ units): \$750.00
12	(2)	Commercial buildings and uses250.00 Non-residential/mixed-use buildings and
13		uses:
14		a. 0-4,999 square feet of gross floor area: \$300.00
15		b. 5,000-24,999 square feet of gross floor area: \$750.00
16		c. 25,000+ square feet of gross floor area: \$1,000.00
17	(3)	Special exceptionsAccessory, including structures, signs, and lot dimension
18		variances: \$250.00

(4) Subdivision-related variances: Base fee + \$25 for each proposed lot
