# 2015 Public Integrity Bureau Annual Report

PIB shall include in its annual report a summary of each misconduct complaint, including a description of the allegation, the final approved disposition, and any discipline imposed. PIB's annual report shall also include aggregate misconduct data showing the number of each type of complaint and the number and rate of sustained cases after final approval, and shall provide an analysis of this data that identifies trends and concerns and documents NOPD's response to the identified trends and concerns. The PIB and IPM should coordinate and confer with each other in collecting, analyzing, and reporting this data to avoid or minimize duplication of efforts or resources. [Consent Decree ¶426]

The Public Integrity Bureau (PIB), commanded by Assistant Superintendent Arlinda Westbrook, is responsible for the fair and consistent implementation of the disciplinary process, from the receipt of a complaint through its final resolution. The includes the assignment and processing of all disciplinary investigations, review of recommendations in all disciplinary investigations and hearings, maintenance of disciplinary records, and the coordination of specific investigations with outside agencies such as the Federal Bureau of Investigations and the Independent Police Monitor.

All bureaus and divisions are included in the disciplinary process. Although officers assigned to PIB investigate all allegations of criminal misconduct against both police officers and civilian employees, the investigation of violation of administrative regulations are shared with first-line supervisors. In order to hold first-line supervisors accountable and ensure their involvement in complaints against their subordinates, many administrative complaints are forwarded to division commanders through their bureau chiefs for investigation. These investigations are reviewed through that bureau's chain of command, then ultimately by PIB and Superintendent of Police Michael Harrison.

The purpose of this report is to summarize misconduct complaint data collected for the past year, analyze that data, and identify trends and concerns in the areas of misconduct and discipline. The report includes: the number of sustained, not sustained, exonerated and unfounded complaints; the number of officers who were subjects of repeated misconduct complaints; the number of officers arrested for on-duty and off-duty conduct; the number of criminal prosecutions of officers; and the number and nature of civil suits filed against New Orleans police officers for work-related conduct. The report describes steps NOPD has taken to correct problems and to build on successes.

# Key definitions

**Complaint**—Any allegation of misconduct committed by any NOPD employee that is reported by any person, including any NOPD employee.

**Exonerated**—The outcome of a disciplinary investigation in which a preponderance of the evidence demonstrated that the alleged misconduct occurred but did not violate NOPD policies, procedures, or training.

**Formal Disciplinary Investigation**—Internal New Orleans Police Department investigation that may result in disciplinary action as set forth in Civil Service Rules.

**Misconduct**—Any action or inaction that violates any Departmental Rule, Policy, Procedure, Order, verbal or written instruction, or criminal law.

**No Formal Investigation Merited (NFIM)**—A complaint action in which the allegation, on its face, does not constitute a violation by an employee of any Departmental Rule, Policy, Procedure, verbal or written instruction, or criminal or civil law.

**Not Sustained**— The outcome of a disciplinary investigation in which a preponderance of the evidence did not demonstrate that the alleged misconduct occurred.

**Sustained**— The outcome of a disciplinary investigation in which a preponderance of the evidence demonstrates the alleged misconduct occurred.

**Unfounded**—The outcome of a disciplinary investigation in which a preponderance of the evidence demonstrates the alleged misconduct did not occur or did not involve the accused officer or employee.

# Relevant Policies


Chapter 52.1.1, "Misconduct Complaint Intake and Investigation," became effective on July 19, 2015, replacing former Policy 1020. This new policy, which governs the NOPD's investigation of misconduct complaints, was approved by the Office of the Consent Decree Monitor (OCDM) and the Department of Justice (DOJ), and it is fully compliant with the Consent Decree.

Policy 1021, "Disciplinary Hearings/Penalties" governs the procedure for conducting disciplinary hearings and determining appropriate penalties. However, it is scheduled to be replaced by Chapter 26.2, "Adjudication of Misconduct," and Chapter 26.2.1, "Disciplinary Matrix" in mid-May. Both policies have been approved by OCDM and the DOJ.

Chapter 52.2, "Negotiated Settlement Agreements," became effective November 15, 2015, replacing Policy 1023. The policy allows for resolution of misconduct complaints for minor violations reported by supervisors without a formal hearing. It was revised to allow for negotiated settlements involving body-worn camera violations. Policy 1025, "Community-Police Mediation," which allows for mediation as an option in conflict resolution of citizen complaints, is currently under review and may be revised in collaboration with the Independent Police Monitor. Chapter 35.1.7, "Non-Disciplinary Employee Counseling for Minor Violations," was converted to chapter format; it became effective May 10, 2015. That policy allow for counseling or training as resolution of minor violations or infractions.

# The Complaint Process

The following flow chart describes the misconduct complaint process:



When anyone files a complaint against a New Orleans police officer, the Public Integrity Bureau of the New Orleans Police Department conducts an investigation. Upon receiving a complaint, the Public Integrity Bureau reviews, classifies, and processes the complaint. An investigator may contact the complainant and obtain a recorded statement. The investigator will ask the complainant to provide as much detailed information as possible regarding the incident.

The investigator will contact all available witnesses, including police officers, examine all relevant evidence, and gather all information pertinent to each allegation. If for any reason there is a lengthy delay in the investigation, the complainant will be notified as to when he or she can expect to receive the results. After all allegations have been fully investigated, the Superintendent of Police will determine what action, if any, should be taken to resolve the complaint.

The investigation may result in several outcomes, depending on the final disposition of the complaint. If the disposition is exonerated, unfounded, or not sustained, no disciplinary action will be taken. In all cases, the person who made the complaint will be notified in writing of the investigator's findings.

When an allegation is sustained, the matter may proceed to a disciplinary hearing at which time a penalty will be recommended. The Superintendent of Police ultimately determines what penalty is appropriate. The penalty may range from a reprimand to suspension, fine, demotion, or dismissal from the department.

If the complaint includes allegations of criminal wrongdoing, a criminal investigation may be conducted in addition to any administrative investigation. The District Attorney may then be consulted regarding the filing of criminal charges and the possible arrest of the offending employee.

# Misconduct complaint findings<sup>1</sup>

In 2015, the Public Integrity Bureau (PIB) processed 850 misconduct complaints, including 549 lodged by members of the public (65 percent) and 301 that were initiated by NOPD supervisors, i.e. officers who have the rank of sergeant or higher (35 percent). Of the rank-initiated complaints, 52 of them (17 percent) resulted in non-disciplinary counseling or training. The total number of complaints in 2015 is 2 percent lower than the total number of complaints in the previous year, 870. This decrease is not apparently related to access to the complaint process.

Analysis of these data reveals several encouraging trends. For example, the total number of complaints continues to decrease. In 2013, PIB received a total of 994 complaints; in 2015, it processed nearly 15 percent fewer complaints. The number and percentage of citizen complaints are also decreasing, from 654 in 2014 (75 percent of the year's total) to 549 in 2015 (65 percent of the total). This downward trend occurs at a time when the New Orleans Police Department has bolstered community awareness of the misconduct complaint process through stronger outreach. For example, informational placards have been posted at every district station and police facility open to the public during 2015. These placards notify citizens in three different languages (English, Spanish, and Vietnamese) how to make a complaint against a police officer or Department employee. The Department also created a detailed PowerPoint presentation for the public that explains the misconduct complaint process; the file is available on the NOPD Web site (visit http://www.nola.gov/nopd/citizen-services/complaints/).

Although several factors may have contributed to the downward trend, the Department believes fewer complaints suggests improved performance by NOPD officers in their law enforcement duties. The reforms and best practices implemented as a consequence of the federal Consent Decree have not only reaffirmed the Department's commitment to effective, constitutional policing, but are improving officers' relationship to the New Orleans community, including residents and non-residents.

Concomitant with the lowered percentage of complaints initiated by the public is an increased percentage of rank-initiated complaints. In 2014, the number of rank-initiated complaints was 216, or 25 percent of the year's total. In 2015, the number of rank-initiated complaints was 301, or 35 percent of the year's total. This increase is primarily attributable to the Department's intensified focus on discipline and accountability, as well as policy changes that resulted in more violations. For example, the Department implemented a strict disciplinary policy on body-worn cameras (BWC) that mandated suspension for failure to activate a BWC in certain situations, including any contact with citizens. Of the complaints processed by PIB in 2015, about 7 percent involved allegations of BWC non-use or misuse.

Although the Department is very focused on discipline, both as a function of command and as a means of public accountability, NOPD continues to explore alternatives to punishment in appropriate situations. For example, remedial training, redirection, and counseling can be an effective way to resolve minor administrative violations. In collaboration with the Independent Police Monitor, PIB attempted 43 police-community mediations in 2015, of which 23 were successfully mediated (20 were returned for investigation). In 2015, PIB recommended 18 cases for negotiated settlements, and 15 of those were successful. The settlement process, which is available only for rank-initiated complaints, is available for officers who agree not to contest the allegations against them.

The following summaries describe all of the misconduct complaints lodged against New Orleans police officers and police department employees through the Public Integrity Bureau in 2015. The complaint process of the New Orleans Police Department is allegation-driven, and all allegations are taken seriously and investigated thoroughly. However, until a complaint is proven, allegations contained in the complaint have not been verified and should not be read as statements of fact.

Additionally, a "sustained" disposition does not necessarily indicate that the complaint's allegations have been proven. Misconduct complaints often contain multiple allegations, and a "sustained" disposition reflects the fact that at least one allegation was proven to be true by a preponderance of the evidence. In some cases, an investigator may discover additional allegations that are not contained in the original complaint; therefore, a case may be given a "sustained" disposition even when none of the complainant's allegations are proven.

Finally, a complaint may be given a "sustained" disposition when an investigation is completed, but that disposition may change once the complaint is adjudicated during a disciplinary hearing. The disposition of a complaint is not considered final until after the disciplinary hearing is held and the Superintendent of Police has approved the disposition and discipline. Consequently, the disposition of cases for which the discipline is listed as "hearing pending" may ultimately be changed.

# 1. Complaint Tracking Number: 2015-0001-R

The victim of a theft called NOPD several times to have officers report to her location to take her report. When the victim's daughter called, she was told by an unknown complaint operator, "it didn't matter, call whoever you want."

Officer arrested in St. Bernard Parish for a domestic disturbance.

# 4. Complaint Tracking Number: 2015-0004-C

The complainant stated he had been inside his residence engaged in a verbal altercation with his girlfriend. The altercation turned physical when his girlfriend armed herself with a knife and stabbed the complainant in the left biceps. The complainant continued by stating after speaking to the police at the hospital he was arrested and charged with aggravated battery on his girlfriend. The complainant felt that the officer came to the conclusion that he was the aggressor in the incident when his girlfriend should have been arrested for attacking him.

# 5. Complaint Tracking Number: 2015-0005-N

Officer allegedly was unprofessional by calling an attorney a thief. Preliminary investigation revealed the officer was retired from the NOPD

# 6. Complaint Tracking Number: 2015-0006-C

Complainant was approached by an officer with a gun drawn while he was walking to work because complainant was carrying a weapon in a secured holster. He advised officers he was complying with open carry laws. The accused officer's partner reminded accused officer that he had a right to open carry.

The complainant alleged that two 911 operators may have violated department policy when they failed to send a unit to a call for service.

Complainant alleged that, when an officer responded to a vehicle accident, the officer appeared to not know what to do. The officer allegedly failed to take information about the driver's passengers until the driver offered it, and the driver felt that the officer was neglectful in his duties.

### 11. Complaint Tracking Number: 2015-0011-R

An officer responded to a call for service at a hotel, which involved a female striking a male while the male was trying to vacate their room. The officer checked for bodily harm on both parties involved, verified their identity via their state driver's license and released both in a timely manner. The officer then assisted hotel security with escorting one of the parties to the front desk where he was assigned another room. The officer is accused of failing to write a report per Department policy.

Disposition: Not sustained

# 12. Complaint Tracking Number: 2015-0012-C

Complainant alleged that an accident report was missing one driver's insurance information. The complainant allegedly called numerous times regarding missing information. Several drafts of the report have been prepared, but the report is allegedly still incorrect.

# 13. Complaint Tracking Number: 2015-0013-R

Officers observed a traffic infraction and elected to conduct a traffic stop on the target vehicle. Upon the vehicle stopping, the front seat passenger exited and fled on foot. Officer gave chase to that subject before losing sight of him. Meanwhile, the rear passenger also fled the vehicle. Complainant alleged that an officer used unauthorized force by kicking at an arrested subject and was unprofessional by shouting vulgarities.

Disposition: Sustained

# 14. Complaint Tracking Number: 2015-0014-C

The complainant, who was the victim of a battery, told officers that the man who beat her was a "drug dealer and a killer." The complainant alleged that the perpetrator called her and advised her of the officer's statements which resulted in the perpetrator threatening her. The complainant alleged that the officers relayed her statements to the perpetrator.

Disposition: Exonerated

# 15. Complaint Tracking Number: 2015-0015-R

Officer failed to label and categorize his body-worn camera (BWC) videos as instructed.

Disposition: Sustained

Discipline: Eight-day suspension

# 16. Complaint Tracking Number: 2015-0016-D

Officer was attending a meeting at a district station when he engaged in a verbal altercation with another sergeant.

Disposition: Sustained

Discipline: Counseling

# 17. Complaint Tracking Number: 2015-0017-C

The complainant stated she called the police because her son and his girlfriend were involved in a verbal altercation over her son's cell phone. The girlfriend began striking her son about the head with her hand. The police were called. After speaking with the son's girlfriend, her son was arrested for domestic battery. The complainant said the officers framed her son.

Disposition: Not sustained

# 18. Complaint Tracking Number: 2015-0018-N

An officer almost hit the complainant and her boyfriend with a car while they were walking on the sidewalk. The officer allegedly exited his vehicle in an apparently aggressive manner. The boyfriend did not want to get involved and complainant could not determine who officer was.

Disposition: No formal investigation merited

# 19. Complaint Tracking Number: 2015-0019-N

The complainant stated he is the manager of a security firm. An applicant became upset when he learned the company handled government contracts. He then pulled out a wallet with an NOPD badge set which identified him as a NOPD Lieutenant and became aggressively shouting obscenities at the complainant. The complainant stated that the applicant advised he was a former full time NOPD Officer but is currently a Reserve NOPD Officer. A review of NOPD records revealed no such record of the identified person as having been a former or current reserve NOPD Officer.

Residence was burglarized and it allegedly took seven hours for officers to arrive; officer allegedly was unprofessional and called stolen TV "cheap."

Complainant was searched by an officer and felt the search was illegal.

Disposition: Sustained

### 22. Complaint Tracking Number: 2015-0022-C

Complainant alleged that an arrest warrant charging him with theft was improperly issued. The complainant stated he had been hired to do a contracting job which involved putting up a fence on his client's property. Prior to finishing the job the complainant became ill and needed to be hospitalized. During the complainant's hospital stay the last piece of the materials needed to finish the job (gate) arrived at the store it was ordered from. However, it was the wrong article and the client returned it and kept the money. When the complainant was released from the hospital and attempted to finish the job he learned the client had not reordered the correct item and expected him to pay for the item. The complainant stated the contract between he and the client stated otherwise. The complainant advised the client when she retrieved the gate he would install it. The complainant alleged that an officer had a personal relationship with his client that caused her to pursue the arrest warrant for theft.

The complainant stated the argument escalated when the woman punched him in the mouth and facial area causing a laceration to his mouth and chipping his teeth. The complainant then stated he stopped his vehicle at the side of the road and notified the police. According to the complainant, when the police arrived the officer took the statement of the woman's son and then issued him (complainant) a summons for battery. The complainant believes the officer should have been able to determine that the woman was the aggressor in the incident.

A supervisor began to analyze a documented Use of Force incident and discovered the report identified an officer as one of the responding officers. A review of the EPR system revealed a report for a miscellaneous incident was written.

Complainant stated that 1.5 to 2 years ago a deputy dressed in a white shirt and green pants put his hands on her. Complainant stated that she slammed a bottle of tea on the counter four times and the deputy approached her and placed his arms around her neck. Complainant stated she broke away from the deputy and ran around shocked. She then left. Complainant stated that an unknown NOPD officer watched as this was happening.

The complainant, an officer, feels she was transferred without the proper notification. Upon her reporting for duty, there was a family emergency where she was granted furlough. During that time her work classification was changed from annual to leave without pay and then leave without pay-suspended.

# 49. Complaint Tracking Number: 2015-0049-C

An officer was advised by her supervisor that he was transferring her because she had challenged decisions he had made and because he felt she did not appreciate his rank structure. The officer also explained this situation came about after an incident where she discovered the supervisor had allowed civilians to have access to case files which she feels is a violation of NOPD rules and regulations. The officer also stated that the supervisor learned she had filed a formal grievance against him because of his plans to transfer her out of the unit; the supervisor initiated disciplinary action against her concerning a case file issue which had taken place the previous week.
