## **DECISION**

Appellant, ReOinne Gifford brings this appeal pursuant to Article X, § 8(A) of the Louisiana Constitution and this Commission's Rule II, § 4.1 seeking relief from a letter of reprimand dated October 26, 2020. (Exhibit HE-1). At all relevant times, Appellant had permanent status as a Taxicab Investigator. (Tr. at 7, 13; HE-1). A Hearing Examiner, appointed by the Commission, presided over a hearing on October 27, 2020. At this hearing, both parties had an opportunity to call witnesses and present evidence.

The undersigned Commissioners have reviewed and analyzed the entire record in this matter, including the transcript from the hearing, all exhibits submitted at the hearing, the Hearing Examiner's report dated December 29, 2020, and controlling Louisiana law.

For the reasons set forth below, Ms. Gifford's appeal is DENIED.

## I. ANALYSIS

It is well-settled that, in an appeal before the Commission pursuant to Article X, § 8(A) of the Louisiana Constitution, the appointing authority has the burden of proving by a preponderance of the evidence: 1) the occurrence of the complained of activity, and 2) that the conduct complained

of impaired the efficiency of the public service in which the appointing authority is engaged. *Gast v. Dep't of Police*, 2013-0781 (La. App. 4 Cir. 3/13/14), 137 So. 3d 731, 733 (quoting *Cure v. Dep't of Police*, 2007-0166 (La. App. 4 Cir. 8/1/07), 964 So. 2d 1093, 1094). The Commission has a duty to decide independently from the facts presented in the record whether the appointing authority carried its legally imposed burden of proving by a preponderance of evidence that it had good or lawful cause for suspending and terminating the classified employee and, if so, whether such discipline was commensurate with the dereliction. *Abbott v. New Orleans Police Dep't*, 2014-0993 (La. App. 4 Cir. 2/11/15); 165 So.3d 191, 197; *Walters v. Dept. of Police of the City of New Orleans*, 454 So. 2d 106 (La. 1984).

Wesley Pfeiffer, the Deputy Director of Utilities, and Ms. Gifford's supervisor in August of 2020, testified that when he had a meeting with Ms. Gifford in his office about her use of a blender in the office, she became combative and refused to leave his office. (Tr. at 18). In addition, Ms. Gifford, whose work day ended at 3:30 PM, left work immediately after the meeting at 3:00. (Tr. at 22). Billy Byrd, the Operations Supervisor for the Taxicab Bureau and Gifford's immediate supervisor, was in the meeting, and testified that Gifford was loud and that no one gave her permission to leave work. (Tr. at 34-35). Deishon Brown, the Operations Supervisor for the Ground Transportation Bureau, testified that Gifford was "angry" and "yelling," and when Gifford left Pfeiffer's office, Brown heard Gifford say, "Y'all can take his bullshit because I am not," and "He's going to learn to respect me." (Tr. at 40-42).

The Appointing Authority has carried its burden of showing that the complained-of conduct occurred. Ms. Gifford behaved in a disruptive and unprofessional manner, in violation of CAO Policy Memo 83 and the Standards of Professional Behavior of the Department of Safety & Permits. (Ex. DPS-1; Ex. DPS-2). Ms. Gifford's conduct impaired the efficiency of the public

service, as Ms. Gifford was disruptive, disturbing other employees and employee morale. (Tr. at

56). The undersigned Commissioners further find that the penalty is commensurate with the

infraction.

The appeal is DENIED.
