ORDER

The New Orleans Public Library (NOPL) moved for summary disposition of McCormick's appeal on the basis that the appeal is now moot. The Commission heard oral argument on this motion at its April 10, 2026, regular meeting.

McCormick's appeal concerned unpaid holiday pay while she was on medical leave. Under Civil Service Rule IV, § 13.2, employees on leave without pay before or after a holiday are not eligible for holiday pay. Once NOPL processed the sick leave donation, it reimbursed McCormick for the holiday pay at issue. The appeal is now moot and is dismissed under Civil Service Rule II, § 6.1(e).
