The unique requirement of this position such as knowledge of hazard mitigation and disaster management, plus policy development and intergovernmental relations experience limits the applicant pool. Mr. Mast is the ideal candidate for this position.

Mr. Mast has extensive, direct experience in managing large, complex hazard mitigation projects and translating these projects to support policy development at the local, state and federal levels. In addition, Mr. Mast holds advanced academic degrees and a CFM certification, the latter of which is not required at the time of hiring (but newly hired employees are expected to obtain within the probationary period).
