ORDER

The Chief Administrative Office moved for summary disposition of Mr. Cerami's disciplinary appeal on the basis that he has no right of appeal as a probationary employee. The Commission heard oral argument on this motion at its regular meeting on May 30, 2024.

Mr. Cerami's one-year probationary period began on August 20, 2023, and he was terminated on April 22, 2024. Civil Service Rule II, § 4.1 grants a right of appeal to "[r]egular employees in the classified service." A "regular employee" is "an employee who has been appointed to a position in the classified service in accordance with the Law and these Rules and who has completed the working test period." Civil Service Rule I(64). Mr. Cerami was a probationary employee, so he has no right of appeal under Rule II, § 4.1.

The Commission grants the Chief Administrative Office's motion for summary disposition.
