ORDER

On September 13, 2023, the Commission denied Ms. Maltseva's appeal of her demotion and 85-day suspension and granted her appeal of a five-day suspension based on a failure to inform her supervisor of an absence. On September 13, 2023, Ms. Maltseva moved for rehearing, and the Commission denied this motion on November 13, 2023. On November 21, 2023, Ms. Maltseva requested an appeal to the Fourth Circuit Court of Appeal. The Commission granted this motion on November 27, 2023. After Ms. Maltseva reviewed the transcript from her hearing following her receipt of a cost letter, she filed a motion to correct the transcript on December 11, 2023.

Instead of requesting the correction of typographical errors or misspellings, Ms. Maltseva raises new arguments about the capacity of the decisionmaker, Thomas Mulligan. Ms. Maltseva also states that the emails entered into evidence by the Appointing Authority lacked the attachments, but she concedes these attachments were entered into evidence at her request. The other substantive criticisms of the transcript likewise lack merit.

Therefore, Ms. Maltseva's motion to correct the transcript is denied.
