ORDER

The Sewerage & Water Board moved for summary disposition on the basis that Mr. James has no right of appeal as a probationary employee. The Commission heard oral argument on this motion at its July 12, 2024, regular meeting.

Mr. James was a probationary employee, so he has no right of appeal under Civil Service Rule II, § 4.1. The Sewerage & Water Board hired Mr. James on July 17, 2023. His six-month probationary period was extended by letter dated January 8, 2024. The Sewerage & Water Board placed him on emergency suspension on April 5, 2024. Mr. James resigned from his employment on May 2, 2024.

Civil Service Rule II, § 4.1 grants a right of appeal to "[r]egular employees in the classified service." A "regular employee" is "an employee who has been appointed to a position in the classified service in accordance with the Law and these Rules and who has completed the working test period." Mr. James had a six-month probationary period under the Commission's former Rule VII, § 1.2. The Personnel Director approved the extension of the probationary period for another six months under Rule VII, § 1.3. Because Mr. James was a probationary employee at the time of his emergency suspension and resignation, he has no right of appeal.
