Reviews proposed stormwater management ordinances including MS4 on zoning practices.

Directs detailed studies and reports (quarterly and annual) for stormwater management to include GIS mapping and analysis, charts, graphics financial statement.

The applicant has a Master's Degree in City Planning an accredited university and six (6) years of full-time professional urban planning experience, of which one (1) year and two (2) months have been in an exempt and unclassified capacity.

The applicant has 4 years and 10 months of experience as an Environmental Planner and Project Coordinator for the Ohio Environmental Protection Agency, where he managed concurrent loan projects for two State Revolving Fund (SRF) programs addressing water infrastructure issues including drinking water, stormwater, and wastewater; with components for CSOs, green infrastructure, and lead water pipes; many of which were required by Long Term Control Plans and identified in capital improvement planning. Other duties included coordinating with loan applicants, government officials, engineering consultants, external agencies (CDBG, USACE, USFWS, OPWC), and internal review teams to meet programmatic, State, and Federal requirements on planning. design, and construction loan projects; conducting NEPA review research including Historic Preservation, endangered species, 208 water quality, floodplain coordination, and alternatives analysis to write environmental assessments (EAs) and Limited Environmental Reviews; reviewed detailed plans, engineering contracts, bid documents, permits, utility rate legislation, financial audits, budgets, and planning information to develop environmental reviews and financial affordability reports; and prepared loan exhibits and agreements, and monitored invoices, disbursement requests, and change orders.

The applicant has 1 year and 2 months of experience has a Hazard Mitigation Consultant for the Ohio EMA. Duties and experience includes: provide support to the State Hazard Mitigation Officer in facilitating FEMA HMA programs (BRIC, FMA, & HMGP) to local jurisdictions through project development, application reviews, Benefit-Cost Analysis, Hazard Mitigation Plan updates, and Environmental Historic Preservation reviews; served as a panelist on FEMA's 2021 BRIC Qualitative Review Panel; researched equity components in the FMA program and used AcrGIS to map Repetitive Loss properties within socially vulnerable census tracts in Ohio using the CDC's Social Vulnerability Index. Research was presented at the 2021 FEMA Region 5 Fall Conference

The applicant's other relevant experience includes serving as the Project Manager for a Hazard Mitigation Plan update, and a subject matter lead for a local Sustainability Plan, while in graduate school; and an Internship at the US EPA in Public Affairs.

The applicant's other qualifications include a Bachelor's Degree from Ohio Wesleyan University where he double majored in Economics and Environmental Studies, a Professional Certificate in Municipal Finance, and is certification as a LEED Green Associate.

It is essential the candidate filling this position has the ability to seek and obtain funding. The candidate recommended for higher salary due to advanced qualifications and experience.

SWBNO will not have to hire consulting engineering firm to apply for State Revolving Loan Funds, IIIA Funding and HMGP Grants. These applications can be completed in-house with the candidate filling this position leading the working group. An experienced grant writer can make up to \$150 per hour. The hourly rate for the person in this position is \$31 per hour.
