**MINUTE ENTRY**

This matter came before the Commission on July 11, 2025. On April 2, 2025, Ms. Robyn Joseph, Appellant, filed a motion to appeal her judgment of March 3, 2025 to the 4<sup>th</sup> Circuit Court of Appeal. The Commission granted the appeal. On April 24, 2025, in accordance with La. C.C.P. art. 2126(A), the Department of Civil Service informed Ms. Joseph of the costs to appeal this matter. On May 14, 2025, Ms. Joseph requested an extension of time in which to pay the fees. The extension request was granted. The extended date to pay 4<sup>th</sup> Circuit fees was June 3, 2025. Ms. Joseph has not paid the fees and has not requested an additional extension.

Therefore, because Ms. Joseph has not paid the costs of appeal, which were due on June 3, 2025, her appeal is dismissed.
