


FINAL AGREEMENT

NOW COME the parties, who represent that a final agreement was reached resolving *Bria Dixon v. City Planning Commission*, C.S. Nos. 9676. Pursuant to C.S. Rule II, Section 6.7, the parties herein have agreed to resolve these matters subsequent to a proceeding with a Civil Service hearing.
