2024 Final General Fund Forecast & Differences from Preliminary Forecast

- By State Constitution, Automatic Rollback of City-controlled Mill Rates proportional to Quadrennial Assessment Increase
 - Results in "Revenue Neutral" Forecast for 2024 Property Tax Receipts
 - +\$13.0m from New Construction and additional Personal Property as estimated from most recent Quadrennial Re-Assessment valuation
- NORD and Parks & Parkways Designated Mill Revenues Included in Final Forecast



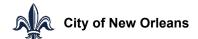
Key Risks to 2024 General Fund Forecast

Fiscal Risks:

- Potential Elimination of Residential STR's = -\$21.8m for General Fund, Special/Dedicated Funds, and Disbursement to Non-City Agencies
- Permitting Process issues remain unresolved and backlog continues
 - Restrains initial permitting operations and revenues; matriculates through process

Potential Remains for Economic Recession

- Local Economy still in Recovery from imposed lockdowns
- Real Estate, Banking, and inflation crises; nationwide job and income disruption would directly impact NOLA commercial and visitor activity
