A high fence with gates is needed to prevent unauthorized entry and theft. Placing a fence along the front of the facility would also expand secure parking and storage space. The items stored at the facility are high cost (spray trucks, airboat, trailers vehicles) and must be properly secured (restricted use pesticides). The fence will place NOMTRCB in compliance with Louisiana Department of Ag and Forestry statues.
