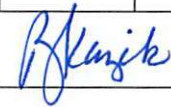

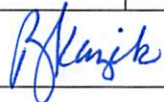

There are currently two control panels in place for representatives to report. One at the first floor main entrance and the other located in the engine room and referred to as the main alarm tower. The controls on both units are malfunctioning and the locations are mis-labeled due to courtrooms and offices being relocated throughout the past years making it very difficult, inefficient and potentially deadly to detect an exact location during an emergency event.
