THE CITY PLANNING COMMISSION WILL HOLD A PUBLIC HEARING ON TUESDAY, MAY 13, 2025, AT 1:30PM IN THE CITY COUNCIL CHAMBER (CITY HALL – 1E07) ON THE 2025 MANDATORY INCLUSIONARY ZONING MARKET ANALYSIS.

2025 MANDATORY INCLUSIONARY ZONING (**MIZ**) **MARKET ANALYSIS PRELIMINARY PRESENTATION** – HR&A Advisors, under supervision by the City Planning Commission, and in coordination with Safety and Permits and other partners, is working to deliver an analysis of the existing Mandatory Inclusionary Zoning (MIZ) policy as described in Article 28 of the CZO. On April 26, 2022, it was determined that a market feasibility analysis is needed to inform changes to the adopted MIZ map and to consider policy modifications based on the following:

- Zoning Districts
- Market Feasibility
- Neighborhoods
- Construction costs
- Other necessary variables

The study will also consider the conversion of vacant office space to residential within the City's Central Business District and explore incentives that could create a viable conversion program. The study team will consider the previous feasibility analysis by HR & A Advisors in February 2019 to inform any changes and make recommendations accordingly.

The purpose of this preliminary presentation for the MIZ Market Analysis is for informational purposes only, and for the public to provide input that can inform the study.
