RETAILS GOODS ESTABLISHMENT STUDY REPORT– The City Planning Commission, in conjunction with the City Attorney, is directed to conduct a study and make recommendations regarding the overrepresentation of and the implementation of distance requirements for the following retail goods establishment use types in New Orleans East: beauty supply stores, nail salons, tire shops and convenience/discount stores, and to make recommendations regarding potential zoning changes that would require conditional use application and approval for the aforementioned retail goods establishment use types.
