Please find the RTA's comment on the TOC study below:

The RTA is excited to comment in support of CPC's adoption of the Transit Oriented Communities Study. As the largest transit provider in the region, we work to provide efficient and useful service that brings people from where they live to all the places they might need to go – at a fraction of the cost to drive. As we plan and design routes to accomplish these goals, we often encounter limitations that are baked into the land-use and development patterns in this city. For example, trying to connect a large apartment complex to a WalMart requires a winding route away from a major thoroughfare through sparsely populated areas. These snake-like and long-distance deviations add time to the route, slowing service and limiting the convenience of transit as a transportation option. Conversely, by limiting housing options in areas with great transit service, people have fewer choices to have a less car-dependent life. Many of these development patterns are a direct result of land-use policy and zoning regulations that have furthered inequity and exclusion. These are the consequences of separating land-use development from public transit planning. On the other hand, true transit-oriented communities (or TOCs) make it easier for RTA to run high-quality service and make transit a more convenient choice for more people, regardless of income. TOCs boost the investments made in transit by making it accessible to more people, businesses and service providers, and RTA can better serve the community. A whole host of other benefits also flow from facilitating this kind of development pattern, such as increased affordability, reduced reliance on private cars, improved walkability, increased retail, and other activities along transit corridors. However, today there are minimal provisions in the zoning code and elsewhere that acknowledge this essential link between land use and transit.

RTA is making significant investments for an improved transit system, including \$42 million for passenger facilities, \$82 million for a zero-emission, resilient bus fleet, and \$300 million for a rapid transit line, called the East-West Bank Corridor. CPC's adoption of the TOC study is the first step in enabling RTA, the City of New Orleans and many other partners to truly explore how transit-oriented communities can show up in New Orleans to boost quality of life, increase access to opportunity, and create a more prosperous, equitable city. The RTA is ready to work alongside

City and external partners through the recommended working group to develop and implement TOC tools and policies as our next step.
