

COMBINED NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND INTENT TO REQUEST RELEASE OF FUNDS

Publication Date: April 8 – April 23, 2025

This combined notice shall satisfy two separate but related procedural notification requirements. The two procedural notification requirements are (1) Finding of No Significant Impact and (2) Intent to Request Release of Funds. On or about April 24, 2025, the City of New Orleans Office of Community Development will submit a request to the U.S. Department of Housing and Urban Development for the release of grant funds under the project known as “Cut Off Natatorium”. The project includes new construction of a natatorium/swimming pool adjacent to the Cut- Off Recreation Center on vacant land. The project is located adjacent to the north of the Recreation Center addressed at 6600 Belgrade Street, New Orleans, Orleans Parish, Louisiana 70131. The parent tract is identified as “PROP SOLD BY LACOSTE SQ 1 PT 28 7/20/19 PT PLOT 33 39/112/105 BELGARDE PTPL 33 557/540X450/332 OR 4.99 ACS PATTERSON TO GEN MEYER”. The construction area is approximately 7,000 square feet, with center coordinates of 29.92410 N / 89.98281 W. The project will be funded through a Community Project Funding Grant in the amount of \$4,000,000.00 under grant #B-23-CP-LA-0624. The total project cost from all sources for this phase is approximately \$4,000,000.00.

FINDING OF NO SIGNIFICANT IMPACT

The City of New Orleans has determined that the project will not have a significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Any individual, group, or agency disagreeing with this determination, or wishing to comment on the program may submit written comments to this office. All comments received by April 23, 2025, will be considered by this office prior to the authorizing submission of a request for release of funds. RELEASE OF FUNDS:

The City of New Orleans certifies to HUD that Tyra Johnson Brown, Director of Housing Policy and Community Development in her capacity as Certifying Officer for Environmental Review for the City of New Orleans consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of New Orleans to use Program Funds.

OBJECTIONS TO RELEASE OF FUNDS:

The U.S. Department of Housing and Urban Development will accept objections to its release of funds and the City of New Orleans' certification received by May 9, 2025, or a period of fifteen days from its receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer or other officer of the City of New Orleans; (b) the City of New Orleans has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by the City of New Orleans; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to:
