



MAYOR'S OFFICE OF CRIMINAL JUSTICE COORDINATION

Introduction

Currently, the Criminal Justice Council allocates money to grantees with funding from Edward Byrne Memorial Justice Assistance Grants from the State (Byrne JAG – State), Edward Byrne Memorial Justice Assistance Grants from the Federal Government (Byrne JAG – Federal), State Victims of Crime Act (VOCA) Grants, Violence Against Women Act (VAWA) Grants, State Office of Juvenile Justice and Delinquency Prevention, and the Paul Coverdell Forensic Science Improvement Program. These funds are administered by the Office of Criminal Justice Coordination. The amounts, grantees and types of programs are listed below for 2014:

Byrne JAG – State

Amount: \$703,852

Grantees: Criminal District Court (2), District Attorney's Office (3), New Orleans Police Department, New Orleans Health Department, Coroner's Office

Types of Programs: Byrne JAG state grants are currently supporting law enforcement task forces; drug testing and interventions; domestic violence monitoring; records preservation and improvement; and youth violence programs.

Byrne JAG – Federal

Amount: \$526,970

Grantees: Sheriff's Office (2), Municipal Court/ New Orleans Health Department, Orleans Public Defenders (2), New Orleans Police Department (2), Mayor's Office

Types of Programs: Byrne JAG federal grants are currently funding correctional surveillance; drug treatment and evaluation; technology upgrades; a federally mandated program for representing juveniles charged as adults; an integrated social service system; a gun abatement program; and a program to support alternatives to youth incarceration.

VOCA

Amount: \$756,152

Grantees: Metropolitan Center for Women and Children, New Orleans Family Justice Alliance (2), CASA, Catholic Charities, Children's Bureau (2), Children's Hospital, Civil District Court, District Attorney's Office, Family Service of Greater New Orleans

Types of Programs: VOCA grants are currently funding counseling and treatment programs for victims of domestic violence, child abuse, and sexual assault; and legal assistance to victims of domestic violence.

VAWA

Amount: \$343,073

Grantees: New Orleans Police Department (2), District Attorney's Office (2)

Types of Programs: VAWA grants are currently funding overtime for the NOPD Sex Crimes Unit, and legal assistance, counseling, and screening for domestic violence cases.

OJJDP

Amount: \$58,374

Grantees: Juvenile Court, Juvenile Regional Services/ Louisiana Center for Children's Rights

Types of Programs: OJJDP grants are currently funding a youth advocacy program and a recidivism reduction program.

Coverdell

Amount: \$10,776

Grantees: New Orleans Police Department

Types of Programs: Funds provided to expand the capacity of NOPD's latent print unit.
