AN ORDINANCE to amend and reordain Section 2-1121 of the Code of the City of New Orleans relative to the Office of the Independent Police Monitor to amend the public reporting requirement deadline; and to otherwise provide with respect thereto.

1 **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**

2 **ORDAINS**, That Section 2-1121 of the Code of the City of New Orleans is hereby amended and

3 reordained to read as follows:

4 **“Sec. 2-1121. Office of the Independent Police Monitor**

5 *******

6 (16) *Public reporting requirement.* The independent police monitor shall be required to issue at
7 least one public report each year, by May 30, to the ethics review board and New Orleans City
8 Council detailing its monitoring and review activities and the appropriate statistical information
9 from the internal investigations office, and other divisions of the New Orleans Police
10 Department. The independent police monitor shall be required to report upon problems it has
11 identified, recommendations made and recommendations adopted by the New Orleans Police
12 Department. The report shall also identify commendable performance by the New Orleans Police
13 Department and improvements made by the department to enhance the department's
14 professionalism, accountability, and transparency. The criminal justice committee of the New

15 Orleans City Council shall conduct a hearing on each annual report within 30 days of
16 submission. Additional reports relating to policy and training recommendations, matters of
17 significant public interest, or other concerns may be issued throughout the year, such reports
18 shall be submitted to the ethics review board and criminal justice committee of the New Orleans
19 City Council and simultaneously released to the public. The committee will have discretion as to
20 whether to conduct a public hearing relating to such reports.
