

To My Fellow New Orleanians:

Since coming into office 1,627 days ago, I have spoken often of our hopes for New Orleans. We are working to become a safer city where every resident can get a good-paying job and where every child has access to an excellent public education. We are committed to reorganize how government works so people can get the services they deserve; a city whose government is open and honest.

Over the past four years, we have taken enormous strides to get this city on the right path. In partnership with the City Council and based on important feedback from you, we have identified priority capital recovery projects in each council district, from community centers to pools to playgrounds to vital public safety infrastructure. As additional FEMA Public Assistance funds are appropriated, we will be able to add projects to that thoughtful list.

Since taking office, my administration has met with FEMA over 635 times, producing an additional 2,005 projects totaling \$1 Billion more in recovery assistance for the City and the Sewerage and Water Board to repair buildings and critical infrastructure like water pipes and streets. This year's Capital Budget reflects committed funding for those projects.

In this 2015 capital budget of over \$265 million, every dollar will be affiliated with a project or program. In 2015, we are budgeted to move forward on dozens of public facilities like construction of a new terminal facility at Louis Armstrong Airport, a new consolidated NOFD fire station for Engines 33 and 40 in Algiers, over \$95 million in road repairs as part of the FEMA-funded Recovery Roads Program, and citywide building repairs. In addition, \$10 million will be dedicated to continuing to upgrade our streetlight systems, including converting conventional streetlights to energy-efficient LED streetlights. This is on top of our already large number of on-going improvement projects like the Lafitte Greenway Bicycle and Pedestrian Path, Rosenwald Center in B.W. Cooper, Carrollton Hollygrove Senior Center, Stallings St. Claude Center, Milne Boys Home in Gentilly, Sanchez Center in Lower Ninth Ward, Municipal Yacht Harbor in West End, the New Orleans Juvenile Justice Center in the St. Bernard Area, and the New Orleans Coroner's Complex in Central City.

We are on the right track. With our continued progress, New Orleans is developing into a city of opportunity, with safe neighborhoods, quality schools for all of our children and good-paying jobs here at home.

This 2015 Capital Budget help us to stay the course we've charted five years ago and continue our progress towards becoming a world-class city.
