

#### To My Fellow New Orleanians:

Over the past six and a half years, we have taken enormous strides to get this city on the right path. In partnership with the City Council and based on important feedback from you, we have identified priority capital recovery projects in each council district, from community centers to pools to playgrounds to vital public safety infrastructure to drainage and streets. As additional FEMA funds have been awarded, we were able to add even more projects to that thoughtful list.

Since taking office, my administration has met with FEMA over 800 times, producing over \$1 billion more in recovery assistance for the City and the Sewerage and Water Board to repair buildings and critical infrastructure like water lines and streets. This year's Capital Budget reflects committed funding for those projects.

In this 2017 Capital Budget of close to \$872 million, every dollar will be affiliated with a project or program. We are budgeted to move forward on dozens of public facilities like construction of a new terminal facility at Louis Armstrong Airport, renovation of the Main Library on Loyola, Village D'Lest Multi-Purpose Building, Gert Town Natatorium/NOPD 2<sup>nd</sup> District Police Station, a record \$480 million in road repairs, drainage, sewerage, water line and stormwater management projects. This is on top of our already large number of on-going improvement projects like the Criminal Evidence and Processing Center, Milne Gym Renovation in Gentilly, Municipal Yacht Harbor in West End, and the Keller Community Center in Central City.

We are on the right track. With our continued progress, New Orleans is developing into a city of opportunity, with safe neighborhoods, quality schools for all of our children and good-paying jobs here at home.

This 2017 Capital Budget helps us to stay the course we charted six and a half years ago and continue our progress towards becoming a world-class city.
