### I. Background

# Landrieu Administration Budget History Fiscally responsible budgeting each year to restore City's finances and build a fund balance

- Focused on eliminating \$97M structural deficit and closely monitoring the budget
- Grew revenue over the past 6 years due to increasing property values, attracting more retail, and improving collections
- Invested in the priorities of New Orleanians:
  - Public safety
  - Economic opportunity and job creation
  - Infrastructure streets, streetlights, sewer and water construction
  - Opportunities for our kids
  - Affordable housing and quality of life
- Built a stable fund balance with revenues over the past 6 years
- Liabilities remain: OPSO consent decree demands

Fiscal responsibility has resulted in the City's highest-ever credit rating and new confidence in the City

### 2017 Budget Approach

#### Prioritize basic services and quality of life

- Spend on priorities:
  - Public Safety
  - Infrastructure
  - Quality of Life

- Job Creation
- Affordable Housing
- Given always present looming liabilities, this budget cuts administrative departments by 3-5%:
  - Mayor's Office
  - CAO's Office
  - Law Department
- Resources will be used on operational departments including:
  - Department of Public Works
  - Police Department
  - Fire Department
  - Emergency Medical Services
- Parks & Parkways
- Property Management
- Department of Sanitation
- Office of Community Development

### Major Obligations Expected in 2017 2017 presents new budgetary challenges requiring additional funding

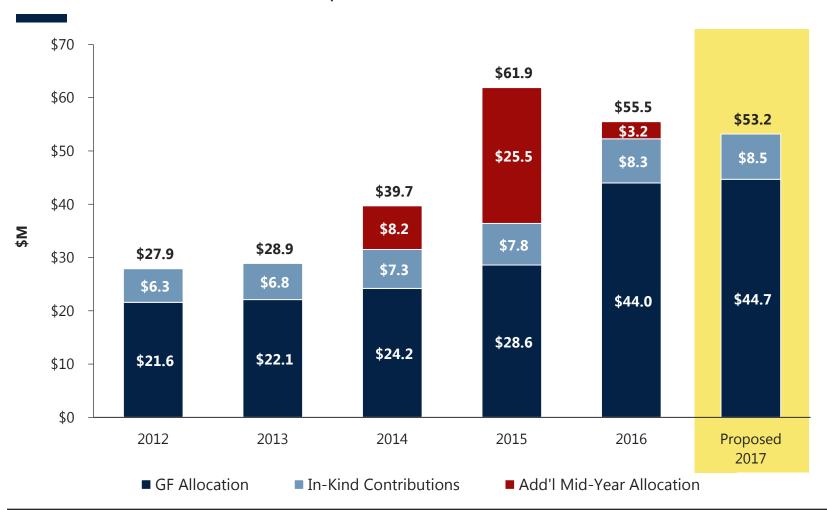
Despite additional revenues anticipated for 2017, demands on the City's funds are constraining the ability to fully fund everything the City needs

- OPSO consent decree requirements
- Increased funding to continue to grow NOPD, fulfill consent decree, and steady funding for NOLA for Life
- NOFD pension
- Courts funded by City general fund
- Criminal Court due to state cuts for City obligations
- Public Defender, DA, and other Courts due to state budget cuts
- Continued cuts to federal grants (HOME & CDBG)
- Recurring funding for street maintenance and streetlights
- Operational costs of new NORDC facilities
- Judgments



#### Orleans Parish Sheriff's Office

OPSO's 2017 funding holds steady at \$44.7M with an additional \$8.5M in in-kind contributions

#### Orleans Parish Sheriff's Office (cont'd)

City expects newly appointed OPSO Compliance Director to achieve cost savings

#### **Court Mandated Timeline**

After 60 days	Finalize a <b>capital plan</b> that addresses housing for mental health inmates and youthful offenders and docks
After 90 days	Finalize a <b>compliance plan</b> that achieves consent decree requirements
After 120 days	Develop a new <b>budget</b> for fiscally responsible jail operations

#### **Recurring New Revenue in 2017**

- \$8.0M from Expansion of Traffic Safety Enforcement Program
- \$1.0M from Superdome Sales Tax
- \$1.5M High Alcoholic Content License Tax

#### Non-Recurring New Revenue in 2017

- \$4.9M Fund Balance for OPSO & NOPD consent decree costs
- \$3.0M BP for DPW to replace 2016 Urban Development Action Grants (UDAG)

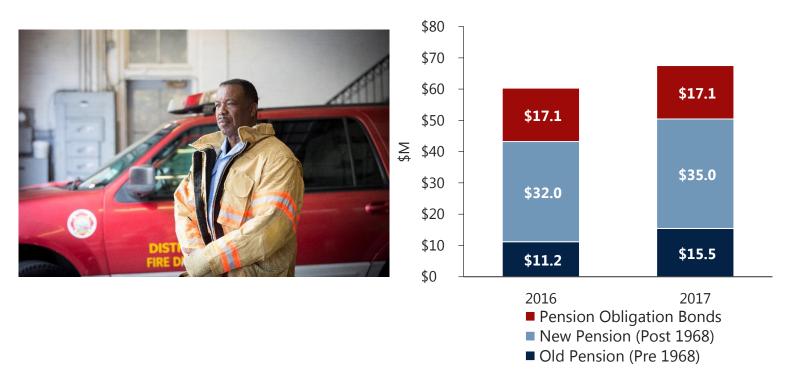

# Result Area: Economic Development & Opportunity





- Economic Opportunity Strategy and Workforce Development
- Promoting cultural economy
- Office of Supplier Diversity fully funded to meet and exceed DBE goals
- Continuing to support the NOLA Business Alliance with \$1.5M to attract jobs and retail



### Result Area: Sustainable & Resilient Communities

- Fixing Our Streets by:
  - \$3M to fill 50,000 potholes and clean 4,500 catch basins
  - \$3M in one-time funding to address the backlog of drainage point repairs to reduce street flooding
  - \$3M for ensuring streetlights are well maintained
- Enhancing Public Spaces by:
  - Additional funding for Parks and Parkways and Sanitation Services
  - New funding to manage and operate the Lafitte Greenway
- Reducing Blight by:
  - Stabilizing Code Enforcement budget through the Neighborhood Revitalization Fund
  - Funding Lot Maintenance Program to clean, cut, and clear blighted properties
- Office of Resilience and Sustainability
  - Provide policy leadership around climate action, urban water management, coastal zone management, environmental quality, and urban mobility
  - Coordinate the implementation of Resilient New Orleans Strategy



# Result Area: Sustainable & Resilient Communities (cont'd)

### Affordable housing initiatives for 2017

#### **Affordable Housing Funding**

- Programs total nearly \$17M in investments in affordable housing in order to:
  - Support low income renters and existing and new homeowners
  - Provide low barrier shelter and additional support for the homeless
  - Maintain elderly, persons with disabilities, and persons living with HIV/AIDS renters and homeowners

#### Neighborhood Housing Improvement Fund (NHIF)

- Working to improve housing conditions and neighborhood stability by:
  - Eliminating blight via remediation and rehabilitation
  - Providing financing and other assistance for homeownership opportunities for families and individuals in existing structures

### Result Area: Open, Effective, & Innovative Government



- Additional funding for One Stop Shop land-use and permitting agencies
- Funding for Civil Service to hire another 5 employees to speed hiring and improve departmental operations
- Supporting 311 services
- Launched DataDriven, the City's open data initiative and RoadWorks



#### 2017 Expected City Judgment Payouts

- \$10M in Certificates of Indebtedness issued in 2016 to pay down certain liabilities and unpaid judgment list
- The City expects to use a total of \$20M through the end of 2017 to satisfy certain liabilities and to pay down outstanding judgments
