Mayor Cantrell's Capital Budget Message



November 1, 2019

To My Fellow New Orleanians:



We enter this year's budget process on the heels of remarkable victory. And while substantial progress has been made, there is much more work to be done. As we look ahead into 2020 and beyond, my administration remains steadfast in its commitment to our residents' shared priorities and common goals.

Together, our City fought for and won a historic agreement to help fund our infrastructure needs using our fair share of the revenue our people generate. That was the first step in an ongoing process to achieve sustainable, well-maintained infrastructure. But this process has also forced us to acknowledge the decades of deferred maintenance on drainage infrastructure that has created a life and death threat to our daily lives; the need for funding to fix our underground infrastructure; and the need for a dedicated funding source to maintain what we build and repair.

But each day, we are continuing to build upon a legacy of investments made in our neighborhoods.

Construction on the new terminal facility at Louis Armstrong International Airport is now complete, underscoring that New Orleans has truly become a world-class city. And we have or soon will complete other important projects like the NOFD Engine 36 Replacement, the Juvenile Justice Intervention Center, The Municipal Yacht Harbor Replacement and the NOPD 4th District Police Station.

We are making great strides on our combined Department of Public Works and Sewerage and Water Board Joint Infrastructure Program that will improve the quality of life for all residents – approximately five percent of the city's settlement has now been reimbursed. We have completed nine projects worth \$25M, there are 12 projects under construction worth another \$80M and we will be kicking off construction on \$40M worth of projects in the coming months. There are another 25 projects that will be advertised before the end of 2019.

We are embracing green infrastructure and finding ways to hold water, because in the face of more intense and more frequent rate of rainfall events, we can no longer rely on our drainage system alone. We broke ground on the \$15.5M Pontilly Neighborhood Storm water network, which will store up to 8.9 million gallons of storm water and reduce flooding as much as 14 inches during a 10-year rain event. We are also progressing with the \$7.1M Hagan Lafitte project, which will reduce localized flooding by storing up to 1.3 million gallons of storm water. And we have put more than \$87M in new projects in design through the HUD-funded Gentilly Resilience District, which will address significant, persistent flooding issues through distinct urban water projects and interventions for homeowners.

In partnership with the City Council, this 2019 Capital Budget proposes nearly **\$734M** in infrastructure improvements. We are budgeted to move forward on **\$674M** in critical road repairs, drainage, sewerage, water line and storm water management projects in each council district. We are addressing our most pressing problems of today while building a strong and successful foundation for the next generation of New Orleanians.

I welcome your support and your engagement in the budget process, and I pledge to you that every cent in this budget is allocated to move New Orleans forward.
