EXECUTIVE ORDER HM 26-09

PRIOR EXECUTIVE ORDERS

I, HELENA MORENO, pursuant to the authority vested in me as the Mayor of the City of New Orleans by Section 4-206(3) of the New Orleans Home Rule Charter and other applicable law, **DO HEREBY ORDER AS FOLLOWS:**

1. **Purpose.** This Order provides relative to Executive Orders issued by the preceding administration.

2. **Revocation.** The following Executive Orders are hereby revoked in their entirety.
 - A. LC 18-02 (Office of Youth and Families) – The functions and duties set forth in this order will be consolidated and managed under the authority of the Deputy Mayor for Health and Human Services, who will aggressively pursue programs and policies to promote and protect the well-being of children, families, and vulnerable populations in the City of New Orleans.
 - B. LC 18-04 (Mayor’s Office of Utilities)
 - C. LC 21-05, LC 22-01, and LC 22-02 (COVID-19-related Orders)
 - D. LC 23-01 (Violent Crime Reduction Task Force) – This advisory committee has been dormant since the departure of its chair, former Orleans Parish Communications District Executive Director Tyrell Morris. The City will continue to pursue all available strategies related to the reduction of violent crime. Strategies for addressing crimes will be managed under the authority of the Deputy Mayor for Public Safety, who is hereby directed to work with a broad spectrum of criminal-justice partners to pursue a coordinated approach to crime-reduction strategies.
 - E. LC 23-03 (Home Rule Charter Advisory Review Committee)
 - F. LC 24-02 (Hurricane Katrina 20th Anniversary Advisory Commission)

4. **Review of Executive Orders.** The Chief Administrative Officer is hereby directed to conduct a comprehensive review of the following executive orders and to recommend any necessary or advisable changes to be promulgated through subsequent Executive Orders. In making the foregoing recommendations, the CAO shall consult, as appropriate, with representatives from the Department of Finance, Department of Law, Department of Health, Department of Property Management, New Orleans Building Corporation, French Market Corporation, Municipal Yacht Harbor Corporation, and other relevant agencies:

- A. LC 18-01 (Procurement Office)
- B. LC 18-05 (Mayor’s Office of Transportation)
- C. LC 18-06 (Budgeting)
- D. LC 20-01 (Procurement of Professional Services)
- E. LC 21-03 (Redevelopment Framework)
- F. LC 21-04 (Youth Master Plan)
- G. LC 24-01 (Municipal Auditorium Redevelopment Advisory Committee)
- H. LC 25-01 (Overdose Fatality Review Panel)

3. **Effective Date.** This Order shall take effect immediately upon signature.
