Domestic Violence Annual Report - 2021

NOPD agrees to track dispositions of domestic violence investigations, including arrests and acceptance or refusal by the DA. NOPD further agrees to make a reasonable effort to enter into Memoranda of Understanding with appropriate agencies to track information related to the outcomes of domestic violence cases, including whether the case was ultimately dismissed, resulted in a plea agreement, or tried, and the final verdict or outcome of the trial. NOPD agrees to track dual arrests and domestic violence arrests by gender. NOPD agrees to publicly report this data on at least an annual basis [Consent Decree ¶222].

Key definitions

Dual arrest – An incident resulting in two or more people arrested for a domestic charge with at least one of the arrestees documented as a victim of a domestic charge.

Domestic violence signals – This report includes the following classifications which could entail domestic violence:

- Domestic aggravated battery
- Simple battery, domestic
- Aggravated assault, domestic
- Simple assault, domestic
- Attempted homicide, domestic
- Domestic criminal damage
- Simple burglary, domestic
- Domestic threats
- Disturbance, domestic

Findings

Incidents and Arrests

NOPD responded to 11,658 calls for service classified under a domestic signal in 2021, and 2,221 of these incidents resulted in an arrest.¹ Dual arrests occurred in 23 (0.20%) of all domestic incidents in 2021. Seven dual arrests in 2021 involved a same sex domestic dispute.

Overall, these incidents resulted in 2,325 individual arrests. Of these arrests, 1,688 (73%) were male and 637 (27%) were female.

¹7,662 (66%) of the calls for service are classified as "Domestic Disturbance," which may not involve a crime.

Arrested Offender Demographics

In 2021, 61% of all people arrested as a result of a domestic dispute were black or African American males.

Charge Outcomes

In 2021, the District Attorney (DA) resolved domestic violence charges against 66 people, of whom 33 were convicted of at least one such charge. As of March 10, 2022, 141 of the domestic violence charges screened in 2021 by the DA were not yet resolved.

Of the 82 domestic violence charges resolved by the DA, defendants were convicted of 40 (49%). Defendants plead to 37 (45%) charges, 4 (5%) were handled through a trial, the DA decided to no longer prosecute (nolle prosequi) 39 (48%), 2 (2%) were quashed as prescribed by the court, none (0%) were dismissed as moot, and none (0%) were referred to another court.

Plea Outcomes

The 37 domestic violence charges resulting in plea agreements included 16 (43%) pleas of guilty as charged, no pleas of nolo contendre (no contest) (0%), and 21 (57%) pleas of guilty to a lesser offense.

Trial Outcomes

Of the 4 charges decided by trial:

- 1 was found not guilty by a judge (25%)
- 1 was found guilty as charged by a judge (25%)

- 1 was found guilty as charged by jury (25%)
- 1 was found guilty of a lessor offense by a judge (25%)


Refused charges

The District Attorney refused 1,732 domestic violence related charges in 2021, none of which were law enforcement-based refusals.² The reasons for the refusals are as follows:

Training

Courses

Recruits receive 40 hours domestic violence training before they enter the field, which consists of Problem Based Learning Exercises after in class courses for Case Law, Interview Techniques, Policy, Domestic Violence Dynamics; Predominant Aggressor, Blueprint for Safety, and Protective Orders and Restraints. Officers and supervisors received three hours of annual In-Service domestic violence training in 2021, including: 1 hour of "Protective Order Registry," 1 hour of "Louisiana Victim Information & Notification Everyday," and 1 hour of "Domestic Violence Intervention."

Roll Call

Supervisors have a meeting at the being of every shift with the officers in their platoon. This meeting is called "Roll Call." The Academy requires supervisors to cover certain topics during roll call each week. For the weeks of March 7-13 and July 4-10 the Academy required supervisors to discuss Chapter 42.4 – Domestic Violence with the officers in their platoon.

Email Blasts

The Domestic Violence Unit sends educational email blasts to the entire Department. On 2/13/21 the DV Unit sent an email informing the Department about a recent update to the DV policy, the department's arrest matrix, and Louisiana's law on "Prescription." On 2/23/21 the unit sent an email to the Department about the information that is necessary for all DV arrests. On 6/25/2021 the DV unit sent an email informing the Department about how to ensure arrest documents and warrant applications meet the requirements for protection orders. On 9/9/21 the unit send an email about how to navigate technical issues with restraining orders resulting from Hurricane Ida. On 11/23/21 the unit sent an email about how dual arrests are discouraged and the circumstances under which they are permitted.
