RIGHTS OF CRIME VICTIMS & WITNESSES

LOUISIANA REVISED STATUTE 46:1841-1844

LARS 46:1841-Legislative intent:

"In recognition of the civic and moral duty of victims and witnesses of crime to cooperate fully and voluntarily with law enforcement and prosecutorial agencies, and in further recognition of the continuing importance of such citizen cooperation to state and local law enforcement efforts and the general effectiveness and well-being of the criminal justice system of this state, the legislature declares its intent, in this Chapter, to ensure that all victims and witnesses of crime are treated with dignity, respect, courtesy, and sensitivity, and that the rights extended in this Chapter to victims and witnesses of crime are honored and protected by the law enforcement agencies, prosecutors, and judges in a manner no less vigorous than the protection afforded the criminal defendants."

The following is a synopsis of your right as provided by Louisiana Law if you are a victim or witness of a felony crime against the person.

YOUR RESPONSIBILITIES:

- You must report the crime within 72 hours unless there are extenuating circumstances.
- You must designate a family member to be the contact for minor or homicide victims.
- You must provide your current address and phone number.

LAW ENFORCEMENT SHALL:

- Ensure that you receive emergency, medical, and social services as soon as possible
- Provide you with a crime victim's brochure



You have the right

- To be notified of the arrest of the accused
- To be present at all hearings, court proceedings and have advance notice of such hearings
- Not to be excluded from any portion of the hearing or trial unless you are a witness and the court orders you to be sequestered
- To be provided with a private setting when being interviewed by law enforcement.
- To be informed as to what you can expect and what is expected of you and how to get information
- To be assisted in informing your employer of the need for you to miss work in order to cooperate with the prosecution of the case
- To be informed as soon as possible of any change affecting your appearance at a proceeding if you are scheduled to appear
- To be provided by the court, with a secure waiting area away from the defendant, his family and friends, whenever possible but always in the case of violent crimes
- To have your attorney confer with the agencies about the prosecution and disposition of the case
- To be consulted by the District Attorney for your view on dismissal, plea bargain, or sentencing alternatives
- To be given specific information about maximum and minimum sentencing and prison terms prior to the sentencing hearing
- To make an oral or written victim impact statement prior to sentencing
- To express your opinion at the sentencing hearing
- To request restitution if the defendant is found guilty
- To have personal property returned promptly when no longer needed as evidence

Once the defendant has been convicted and becomes an inmate, you have the right to be notified:

- When he or she is released
- Of a pardon or parole hearing and the right to be present and make written or oral statements
- Immediately of an escape and within 48 hours of recapture.
- Of the appeal, discharge, or parole of the defendant of a scheduled execution. A family member of the victim may be present.

LOUISIANA COMMISSION ON LAW ENFORCEMENT

Crime Victims Reparations Program Act 250 of 1982, LA Revised Statute 46:1801-1822

Effective July 1982, the State of Louisiana established a program for the payment of compensation to the victims of certain crimes. The law, known as the Crime Victims Reparations Act, created the Crime Victims Reparations Board and established the Crime Victims Reparations Fund. The Board Administers the Acts' provisions and awards payments from the fund. Income for the fund is composed primarily of monies paid as cost levied on criminal court cost. Funds are supplemented by a federal grant, court ordered restitution from criminals, donations and interest.

ELIGIBILITY TO APPLY FOR AWARDS

You may apply if you:

- \rightarrow Believe you are a victim of a violent crime
- → Are the victim's legal representative (his attorney or the person legally responsible for the expenses)
- \rightarrow Are the victim's dependent

A claim maybe filed regardless of whether the offender is known, has been arrested, and/or has been found guilty.

The Crime must:

- \rightarrow Involve the **use of force** or the threat of use of force **AND**
- → Resulted in personal injury, death or catastrophic property loss AND
- \rightarrow Resulted in expenses allowed by the statute and not reimbursable from **any** other source

You may file a claim for **Vehicular crimes** (motor vehicle, boat or aircraft) if you are the victim:

- \rightarrow Of a DWI driver
- \rightarrow Of a Hit & Run driver
- → Of a driver who is fleeing the scene of a crime which he knowingly participated in
- → Whose injuries were intentionally inflicted with a vehicle
